SUMMARY:

Under the direction of the Director of Student and Family Services, provide quality child care and a safe and nurturing environment for preschool-age children in a designated child care center or program; assist the teacher with implementing a variety of activities to meet the needs and interests of the children. The Infant/Toddler Assistant II classification provides classroom support to a teacher in a preschool-age classroom environment. Incumbents assist with various student needs in relation to the age of the children, including assisting with basic feeding and diapering/toileting.

ESSENTIAL DUTIES AND RESPONSIBILITIES: To perform a job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed in the job description are representative of the knowledge, skills and/or abilities required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Provide quality child care and a safe and nurturing environment for preschool-age children in an
 assigned child care center or program; assist in areas of preschool student hygiene, nutrition and
 child care as directed.
- Care for and monitor children during various periods of the day; clean children, clothes and linens
 as necessary; assist children in toileting as appropriate; respond to a child's needs and problems
 in a patient, caring and sensitive manner.
- Participate in activities for preschool-age students as appropriate; ensure that children are interacting in age-appropriate activities; oversee groups of students in games and playground activities; ensure safe outdoor play per established procedures; monitor children on field trips as assigned.
- Provide assigned teacher with support in conducting student observations per established procedures.
- Maintain learning environment in a safe, orderly and clean manner; clean, set up and set out toys
 and instructional materials; facilitate the distribution of snacks or assigned meals per established
 procedures.
- Prepare and maintain reports related to assigned activities; prepare incident and accident reports per established procedures.
- Attend and participate in program-related professional development trainings and orientations as assigned; attend program-related meetings.
- Assist teacher in the preparation of assigned instructional and assessment materials; assist teacher in determining appropriate levels of necessary classroom materials and supplies to meet the needs of the children.
- Operate a variety of classroom related to assigned activities.

Other Duties:

Perform related duties as assigned.

REQUIRED QUALIFICATIONS:

- Correct English usage, grammar, spelling, punctuation and vocabulary.
- · Classroom procedures and appropriate student conduct.

- Interpersonal skills using tact, patience and courtesy.
- Basic record-keeping techniques.

Ability to:

- · Assist in the care of children enrolled in a designated child care center or program.
- Assist with implementing a variety of activities to meet the needs and interests of children.
- · Assist in the preparation of instructional materials.
- Assist with eating, housekeeping and diapering activities as directed.
- Understand and follow oral and written directions.
- Establish and maintain cooperative and effective working relationships with others.
- · Communicate effectively both orally and in writing.
- · Operate standard classroom equipment.
- Observe health and safety regulations.
- Prepare related reports.

DESIRED QUALIFICATIONS:

- Ability to speak, read, and write in English and a designated second language.
- Completion of an Early Childhood Education Health and Safety Class.
