Group 1 - No Charge

Local Non-Profit Organizations/Clubs or associations organized to promote youth and school activities. teacher associations, and school-community advisory councils, and recreational youth sports leagues that charge participants no more than an average of \$60 per month.

Group 2 - Direct Cost

All other non-profit organizations, clubs or associations, including religious organizations and those organized to promote youth and school activities; i.e. civic and service groups such as the Chamber of Commerce, League of Women Voters, etc. whose purpose is to improve the general welfare of the community and whose net receipts are expended for the welfare of the youth or other charitable purposes. *Direct Costs cover the district's cost for supplies, utilities and building maintenance*.

Group 3 - Fair Rental Value

Groups shall be charged fair rental value wen using school facilities or grounds for entertainment or meetings where admission is charged or contributions solicited and net receipts are not to be expended for charitable purposes or for the welfare of the district's students (Education Code 38134)

Note; if an activity is scheduled on a non-school day, i.e. weekends, holidays, vacations, a restroom fee of \$12.00 per hour and a custodial fee of \$50.00 per hour for 2 hr. minimum
