INTRODUCTION

The North Monterey County Unified School District (district) Board of Education (BOE) authorized placement of a general obligation bond on the November 2013 ballot. Bond Measure H was placed on the ballot to serve as a funding mechanism to improve school facilities for North Monterey County Unified School District. Measure H was presented to the voters utilizing the state's Proposition 39 program which requires a measure be passed with 55 percent voter approval. On November 5, 2013 Measure H was passed.

CITIZENS' OVERSIGHT COMMITTEE

Proposition 39 requires the sponsoring school district of an approved measure to establish a Bond Oversight Committee (BOC) to review expenditures, inform the public regarding expenditures, and annually report out to the Board of Education confirming that bond funds were expended in accordance with Proposition 39 requirements. This sixth annual report includes expenditures for fiscal year ending June 30, 2021.

The Measure H Bond Oversight Committee met on the following dates during the past year: December 2, 2020. The following items were reviewed:

- Reviewed and approved meeting minutes.
- Reviewed and accepted the independent audit report from Eide Bailly, dated March 29, 2021, for the period ending June 30, 2020 which concluded, "The results of our tests indicated that, in all significant respects, the North Monterey County Uni

fied School District has properly accounted for the expenditures held in the Building Fund (Measure H) and that such expenditures were made for authorized Bond projects. We also determined that the funds were not used for administrative salaries other than bond project administration.”

CONCLUSION

The Measure H Bond Oversight Committee advises that after its review of expenditures, and to the best of its knowledge, the North Monterey County Unified School District is in compliance with the requirements of Article XIII A, Section 1(b)(3) of the California Constitution. In particular, bond revenue has been expended only for the purposes so described in Measure H. As prohibited by Article XIII A, Section 1(b)(3)(a) of the California Constitution, no funds were used for any teacher or administrative salaries or other operating expenses.
